This electronic handwritten signature process is very similar to the previous paper based one, therefore leading to high user acceptance. Our signature solutions allow signed applications to be immediately processed, thus preventing post-signing manipulation of documents as well as enabling a dramatic business cycle reduction. All information taken from any type of insurance application can be automatically synced into the backend system of the insurance broker and/or provider, either once the agent is reconnected at his work station or in real time through a wireless service. This ability reduces the margin of error by allowing information to go straight to the backend systems, as data is captured only once at the mobile point of sale.

Once the insurance agent, using his laptop and a mobile connection, picks-up a form from the company portal and fills-in the insurance policy's terms, a menu of all required signatures appears. With this, the agent can easily navigate to the exact locations where signatures are required.

The company has equipped each agent with a plug and play signature tablet that is easily connected to the laptop using a USB slot. During the first signing process for each customer, the SIGNificant server also collects the biometric signature traits of the person signing and creates a biometric profile.

Any future changes or additions to this policy will require a biometric signature authentication of the specific signatory. Once all information and signatures are collected, the policy is added to the main server in real-time and an approval is accepted by issuing a policy number. The agent can then email/fax or print a customer copy, and the company only archives the original electronic format.
